Dallas area registrants are encouraged to stay at the hotel. Should election be made, however, to stay at home, or not under the package plan in IPT's block of rooms, there is a supplemental registration fee of \$780 for the Basic and Advanced course and \$470 for the Basic Course only, to cover some of the overhead costs that are a part of the hotel package. For each local attendee or attendee outside of the IPT block of rooms, the supplemental fee covers Monday - Friday buffet breakfast, Monday - Thursday lunch, Sunday - Thursday dinner, refreshment breaks, wireless internet and the daily participant fee charged by the hotel that is applied to audio visual and meeting room space costs.
